### **TERMS OF USE FOR VIRTUAL COMMUNITIES**

**To All Users of this ICID Virtual Communities Web Site (the “Site”): PLEASE READ THESE TERMS OF USE CAREFULLY BEFORE USING THIS SITE. BY SUBMITTING A REGISTRATION OR BY USING THIS SITE, YOU ACKNOWLEDGE YOUR AGREEMENT AND ACCEPTANCE OF THESE TERMS.
